- Christina will share her new Master agreement which may contain a deferment from the District. It could serve as an example of the kind of agreement that would most benefit foundations.
- Paula suggests the Network publishes a white paper on this topic with suggestions for formulating MSAs. Including the difference between community colleges and CSUs and UCs. Tim points out that not all auxiliaries are equal in this debate, and that foundations should be considered differently. He suggests we commission a study to create a case for changing the policy altogether or proposing why the current interpretation is no longer accurate or is too vague.
- Action: collect data to inform why this should be at least deferred. Investigate possible advocacy
 routes that could result in an Advancement line item for funding in the budget. Robert will ask for a
 meeting with the new CA Governor.
- This topic will be included on the next Executive Committee meeting. Constance will include Don Rickner's notes from 2013 and Melissa may facilitate a conversation with the Chancellor's legal counsel.
